In 1986, this family operated and minority business that originated as a prime and sub contractor masonry enterprise diversified its scope of contractual services as a general contractor.

In 1989, BJL expanded its services to include certifications as follows: 8-A, North Carolina Department of Transportation, Historically Underutilized Business (HUB) and Minority Business Enterprise (MBE). With these certifications, BJL launched into contractual consultant and construction management - rendering professional services to owners, vendors, contractors, and construction joint-ventures. More distinctly, contractual services are tailored to the needs of the client in the areas of Inspections, Minority Business Consultant/Coordinator, and. Project Management.

Construction services rendered by BJL have culminated in local, state, and regional honors in recognition of commitment and professionalism. In 1988, BJL Construction Company was awarded the Construction Company of the Year award by Cumberland Regional Improvement Corporation. During that same year, the Company received regional recognition as the Construction Company of the Year in Atlanta, GA. BJL then contended at the national level.
